



**ORDINANCE NO. 1196**

**ORDINANCE ADOPTING THE PREVAILING WAGE  
RATES FOR LABORERS, WORKERS AND MECHANICS  
EMPLOYED BY THE GREEN HILLS PUBLIC LIBRARY DISTRICT**

**WHEREAS**, the State of Illinois has enacted "An ACT regulating wages of laborers, mechanics and other workers employed in any public works by the State, county, city or any public body or any political subdivision or by anyone under contract for public works," approved June 26, 1941, as amended from time to time (820 ILCS 130/0.01, *et seq.*) (the "Act"); and

**WHEREAS**, the Act requires that the Green Hills Public Library District (the "Library District") investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of the Library District employed in performing construction of public works for the Library District.

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Library Trustees of the Green Hills Public Library District, Cook County, Illinois:

**Section 1:** To the extent and as required by the Act, the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in the construction of public works coming under the jurisdiction of this Library District is hereby ascertained to be the same as the prevailing rate of wages for construction work in the Cook County areas as determined by the Department of Labor of the State of Illinois, as of June 5, 2017, a copy of that determination is attached hereto as Exhibit "A" and incorporated herein by reference. The definition of any terms appearing in this Ordinance which are also used in the Act shall be the same as in the Act.

**Section 2:** Nothing herein contained shall be construed to apply to said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of this Library District to the extent required by the Act.

**Section 3:** The Secretary shall publicly post or keep available for inspection by any interested party in the main office of this Library District this determination of such prevailing rate of wage.

**Section 4:** The Secretary shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed, or file their name and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

**Section 5:** The Secretary shall file no later than July 15, 2018, a certified copy of this Ordinance with the Department of Labor of the State of Illinois.


**Section 6:** Pursuant to Section 9 of the Act, as amended by Public Act 100-154 with an effective date of August 18, 2017, the Secretary, or his/her designee, shall cause a notice to be published or posted within thirty (30) days of the adoption of this Ordinance either (a) in a newspaper of general circulation within the area that the determination of prevailing wages has been made, or (b) on the Library District's website with a hyperlink to the prevailing wage schedule for the applicable locality (i.e. Cook County) as published on the Illinois Department of Labor's website. Said notice shall conform substantially to the notice attached hereto as Exhibit "B" and incorporated herein by reference. Such publication or posting shall constitute notice that this is the determination of the Library District and is effective.

**Section 7:** In all Library District public works construction contracts or other written instruments, there shall be inserted a written stipulation that the prevailing rate of wages are revised by the Department of Labor and are available on the Department's official website.




